## **SC1-BHC-22-2019 Mental health in the workplace**

**Type of Call** 2 stage Research + Innovation action (RIA)

**Budget** €2-4 million (overall Budget €30m)

**Deadlines** Stage 1 **02/10/18!** / Stage 2 16/04/19

**Notes:** Ideal for many partners focusing on workplace mental health with solutions and pilots and strong interest across our wider Ecosystems



## SC1-BHC-22-2019 Mental health in the workplace

### Expected impact:

- a Improved mental health and reduced sickness absence in the **EU working population**
- b Positive impact on productivity and economic results of workplaces by **improved policies and action** to promote mental health.
- c Improved policies on mental health in the workplace based on the **broader evidence base** of effective interventions.



## **SC1-DTH-05-2019: Large scale implementation of digital innovation for health and care in an ageing society**

**Type of Call** Public Procurement of Innovative solutions = **PPI**

**Budget** €2-5 million per project €10 million overall

**Deadline** Single stage -24 April 2019

### **Notes:**

Large interest for innovators/pilot sites

Scope of this PPI is to specify, **purchase and deploy** ICT based solutions

We are keen to partner as dissemination and exploitation lead and potential pilot coordinator

**This has be for regions already seeking to procure**



## **SC1-DTH-05-2019: Expected impact**

1. Growing awareness/ use of public procurement to boost ICT innovation
2. Contribution to regulatory and legislative process
3. Contribution of socio-economic evidence base for ICT investments
4. Support initiatives on interoperability and standardisation
5. Creation of economic boundary conditions for ICT innovation in AHA
6. Support public-sector investment strategies
7. Create new opportunities for market uptake
8. Contribute to policy to aid the take-up of AHA ICT solutions



## **SC1-DTH-10-2019: Digital health and care services**

**Type of Call** Pre Commercial Procurement = **PCP**

**Budget** €5-6M million per project €22 million overall

**Deadline** Single stage 14 November **2018 (ie not 2019!!!!)**

### **Notes:**

The Commission are keen to see an established path to innovation and increased opportunities for scale up

Targeting the support of health and care service provider to procure the development, testing and implementation of digital services and communication concepts = ideal for cities and regions looking to procure

Beware 2018 closure although entitled 2019!

We are keen to partner as ECHAlliance and offer routes to ecosystem



## **SC1-DTH-10-2019: Expected impact**

Established path to innovation, evidence of benefits of disruptive technologies that can support the development of sustainable business models, improved user and market engagement....

Evidence in key performance areas i.e., quality in health and care, sustainability of the delivery system and economic value.

Increased opportunities for solution uptake across wider international procurement markets....





## **SC1-BHC-25-2019 Demonstration pilots for implementation of personalised medicine in healthcare**

**Type of call** Two Stage Innovation Action

**Deadlines:** Stage 1 02 October 2018, Stage 2 16 April 2019

**Budget:** Between €18-20 million per project (overall budget €60 million)

### **Notes for Ecosystems**

Interest for Ecosystems for Potential Pilot sites and Innovators

Due to the budget and subject his is liable to be **oversubscribed** so close early collaboration is essential.



## **SC1-BHC-25-2019: Expected impact**

1. Evidence for a PM-based model of care that can be used as a basis for the delivery of new ways of care organisation.
2. Demonstration of the viability and feasibility of PM approaches in real-life settings and at a large scale, exemplifying potential for savings in overall healthcare costs.
3. Widening of PM approaches to include diseases other than cancer and rare diseases.
4. Linking of different actors for healthcare, economy, lifestyle, healthy living and regulation, making use of the multitude of data available.
